<sup>3</sup> In 2016, Auburn formed a task force to look at a growing trend of mental health issues at Auburn as well as other institutions across the country. The report recommended the need to address a lack of personnel and other programming services in the area of mental health. For example, Student Counseling Services has seen a 45% increase in client service visits within the last 5 years. With a growing student population, it has become increasingly difficult to see that all the needs of the students are met.

The tuition and fee schedule proposes to reallocate a portion of the proration fee to a Mental Health Fee, which would still be a part of the overall Student Services Fee. In doing this, we are recognizing the need to dedicate resources specifically to this growing concern while not having an impact financially on the students by instituting a fee beyond what they are currently paying.

The Student Services Fee name did not come about until the Fall of 2014. Prior to that, it was called the Registration Fee (with Proration Fee as a separate line which was rolled in at the same time of the name change). The Registration Fee was titled such when tuition was re-structured in the summer of 2010. Prior to that, there was a registration fee that had some components of the current Student Services Fee, but there were also items that had separate lines on billing statements (transit, SGA Fee, Student Center Bond).

The intention for Fall of 2019 is to index all of these with the tuition growth rate with the exception of the proration fee and the student center bond. In addition to the reallocation of \$7 to the Student Activity Fee from the proration fee, we are also proposing reallocating \$35 to create a mental health fee to help fund student counselors which reduces the proration fee to \$158.
