5. Justification:

We are proposing to raise the number of credits that a masters of arts student needs for the degree from 30 credits to 32 to provide an opportunity for the student to take two semesters of a new course called ENGL 7900 Practicum in Teaching College English. Students would take one credit of ENGL 7900 in each of the semesters of their first year in order to get supervised training in teaching college English and to prepare the students to become teachers of record in their second year of the masters. Students are already taking a one-hour weekly practicum course now for no credit. This change to the curriculum would be to give students credit for work that they are already doing and it would give them a record on their transcript that they had courses in college English pedagogy.

Also in this proposal is the plan to remove the requirement for all master of arts students to take ENGL 7040 Issues and Approaches to Composition, a course which, among other things, was doing much of the same things as the non-credit practicum was. Consequently, we had spread GTA training into a 3-credit course and a non-credit practicum. Offering a 1-credit practicum will solve the problem of where GTA training will be accomplished and it will also allow ENGL 7040 to focus more on issues and approaches to Composition rather than on GTA training in Composition and Literature. We will still plan to offer ENGL 7040 each year, but it will not be required of all masters students.
