We are proposing to raise the number of credits that a masters of Technical and Professional Communications student needs for the degree from 30 credits to 32 to provide an opportunity for the student to take two semesters of a new course called ENGL 7900 Practicum in Teaching College English. Students would take one credit of ENGL 7900 in each of the semesters of their first year in order to get supervised training in teaching college English and to prepare the students to become teachers of record in their second year of the masters. Students are already taking a one-hour weekly practicum course now for no credit. This change to the curriculum would give students credit for work that they are already doing and it would give them a record on their transcript that they had courses in college English pedagogy.
